Subject: Pump Idler Spring – Running Change

Product Type: All BOB-CAT FastCat & Bunton Rocket Models

ISSUE: The pump idler spring has been revised on the FastCat and Rocket models. This change has been incorporated across all FastCat & Rocket models. Manufacturing has initiated a running change to production for the Pump Idler Spring # 38219 to part number 4164128.

ACTION REQUIRED: If any FastCat or Rocket comes in for replacement of the idler spring either in or out of warranty, use part number 4164128.

PARTS INVOLVED: Part # 38219; use part 4164128 for this application. **THIS IS NOT A SUPERSEDE** as the # 38219 is still used in other applications.

PRODUCTS INVOLVED: All Bunton models starting 64229XX, 64231XX, and 642404F
All BOB-CAT models starting 94229XX, 94231XX, and 942404F

WARRANTY: Warranty only applies if the unit fails under warranty. If failure occurs in the warranty period, file a claim as you normally would for any warranty job. This is not a rework.
